I wish to confirm that the Committee on Non-Governmental Organizations reviewed the request of your organization, **Asian-Eurasian Human Rights Forum**, for consultative status with the Economic and Social Council (ECOSOC) during its 2010 Regular Session, which took place from 25 January to 3 February 2010

Upon review, the Committee requested the following clarifications:

Please respond to every single question posted in our letter dated 29 January 2010, reproduced here again for your convenience:

- 1) With regard to the information and materials posted on your website, you state that your website is not managed by you. However, if you are not responsible for approving and placing the materials on your website, which is in your name, then please explain your relationship with those who are managing the contents of your website.
- 2) If other individuals and/or entities are responsible for posting the information on your website, please explain if you have authorized those entities or individuals the use of your name and website, and why.
- 3) Please also explain if it is legal in your country of accreditation or registration to authorize others to use your name and your website without your permission.
- 4) Please list your projects and work in the past 5 years which have been implemented near your headquarters.
- 5) Please also list all the offices and names of representatives in the offices located in areas near your headquarters.

In addition to these questions, this Committee would like to add two additional ones:

- 6) Please explain the relationship with the Worldwide Eurasian Human Rights Forum. In addition, please explain whether you have a separate chapter in Geneva; if so, please provide its name, members and the location of its offices in Geneva.
